Step 1

Please complete all sections of the Securities Transfer Form attached.

Please note that under current tax rules the publicly listed securities you donate from a non-registered account will be exempt from capital gains tax **only if you transfer them in kind.** The capital gains tax exemption does not apply if you sell the securities first and then donate the cash proceeds to us. Your broker or investment advisor will provide the CUSIP # which acts like a transaction number in case the transfer needs to be tracked.

Step 2

Send a copy of the completed transfer form to UNBC's Office of Research and Innovation.

This step is important because securities are transferred without your name attached. When we receive the completed form, with the Donor Information, we can then provide you an accurate tax receipt and appropriate recognition of your valuable gift.

- Following your donation, a charitable receipt will be issued for closing value of the securities on the day it is received by the University.
- UNBC's policy is to sell the donated securities within 90 days, but is generally done within one to three days.
- Consult your professional tax advisor on tax planning and tax matters.
