# November 1st Snapshot FTE Summary 2017 vs. 2016 and Fall Applications 2017 vs. 2016

The following summary compares Fall 2017 Full Time Equivalents (FTE) and headcounts as of November 1, 2017 to Fall 2016 numbers. Fall 2017 application numbers are also compared to Fall 2016 numbers as of the November 1<sup>st</sup> snapshots.

# **Executive Summary:**

#### Fall 2017 FTE summary:

- Total FTE (excluding international fee paying FTE) up 0.8% (19.5)
  - At 79.5% of estimated fall portion of ministry FTE targets
  - At 102.1% of Measure (M)
- Overall registrations up 0.6% (20hc)
  - At 81.4% of estimated fall portion of head count needed to meet ministry FTE targets
  - At 100.9% of Measure (M)

# Fall 2018 applications summary:

- Total applications up 17.5% (176 h.c.) from Fall 2017
  - At 32.1% of Measure (M)
- Total admissions down -7.5% (-29 h.c.) from Fall 2017
  - At 16.5% of Measure (M)
- Total registrations flat n/a (0 h.c.) from Fall 2017
  - At 0.0% of Measure (M)




# Registrations (hc)

- Undergraduate registrations up 1.7% (46hc).
  - o At 77.4% of estimated fall portion of head count needed to meet ministry FTE targets.
  - o At 104.7% of Measure (M).
- Graduate registrations up 2.9% (17hc).
  - o At 107.0% of estimated fall portion of head count needed to meet ministry FTE targets.
  - o At 98.9% of Measure (M).
- Continuing Studies registrations down -67.9% (-38hc).
  - o At 79.3% of estimated fall portion of head count needed to meet ministry FTE targets.
  - o At 59.6% of Measure (M).

#### Included in above numbers:

- International (domestic tuition paying) registrations up 2.1% (3hc).
  - At 108.6% of Measure (M).
- International (international tuition paying) registrations up 21.3% (30hc).
  - At 101.4% of Measure (M).

Total registration up 0.6% (20hc).



#### Notes:

- 1. Measure (M) is a comparator number derived from the average of the last three years official final numbers for the semester being reported on. For example, the Measure (M) for a fall 2017 FTE report would be based on the official final numbers from the fall 2014, 2015, and 2016 terms.
- 2. Ministry targets are based on final year end annualized numbers; in order to come up with estimated term targets the ministry target was broken down based on the average split of FTE UNBC sees between summer, fall and winter terms. Further to this the estimated headcount targets were determined by using the average number of students it takes to generate 1FTE in a given semester and at a given student level.
- 3. International tuition group UG FTE are not included in the % of estimated ministry target calculations.
- 4. The ministry targets proved to UNBC include a portion of "undesignated" FTEs; for the purpose of this report these "undesignated" FTE are used as the target for continuing studies.

UNBC is ranked number 2 in the Primarily Undergraduate category. Maclean's ranking takes a measure of the undergraduate experience, comparing universities in three peer groupings. Those in the Primarily Undergraduate category are largely focused on undergraduate education, with relatively few graduate programs.

The overall ranking is composed of a weighted score:

- 28% Students, including success of students winning national academic awards over the previous five years, as well as student satisfaction results from Maclean's new survey.
- 24% Faculty, including the numbers who have won major national awards and success in securing research grants from three major federal granting agencies.
- 20% Resources, including amount of money available for current expenses per weighted full-time equivalent student.
- 13% Student Support, including percentage of the budget spent on student services, as well as scholarships and bursaries.
- 15% Reputation. This is rated on four categories: Best Overall, Highest Quality; Most Innovative and Leaders Of Tomorrow.

In the National Reputational Ranking, UNBC is 34<sup>th</sup> out of 49 in the Best Overall category.

# 1/ Power Engineers, Boiler, Pressure Vessel and Refrigeration Safety Regulation

# a) Power Engineers, Boiler, Pressure Vessel Regulations:

The Power Plant and ancillary devices and the Bioenergy Plant are currently being operated within the guidelines established under the regulation.

**Regulation Changes:** 

There are no new regulation changes this period that affect our operations.

Note: New regulations are coming in which all Power Engineers in the province of BC will be required to pay fees to maintain their certification.

# b) Refrigeration Safety Regulation

UNBC does not employ anyone with Refrigeration Certification therefore all required work continues to be contracted out to a qualified contractor. A blanket order is currently in place with Inland Controls to carry out any work required.

# 2/ Elevating Devices Safety Regulations

The University is operating within the guidelines established under the provincial regulation.

UNBC does not employ anyone with Elevator Mechanic Certification therefore all required work continues to be contracted out to a qualified contractor. A contract is currently in place with Kone Elevators (until September 2019) to carry out all work required.

# Recent Activity:

Technical Safety BC (formerly BC Safety Authority) issued a new directive in regards to "Jumpers". "Use only an approved jumper kit labeled with your name (Or employee number). Immediately notify your supervisor or manager of any equipment in service with jumpers left on. When job made jumpers are necessary, they shall be brightly colored, numbered, long (36" minimum), Conspicuous, tied in knots with a tage and tracked on the jumper log on the controller door."

This directive, and all others are given to the permit holder (UNBC) but are carried out by the Elevator contractor licensed to work on and maintain our elevators. This directive has been reviewed with Kone.

All other UNBC elevating devices were also inspected on Oct 19, 2017 in preparation for a campus wide upgrade and strategic routine capital plan.

# 3/ Electrical Installation and Operating Regulations

All electrical installations and operations also fall under Technical Safety BC.

The University has always required the oversight of a Field Safety Representative (FSR). Historically we have employed a certified Electrician with this designation and continue to do so.

The only relevant change in this area is that the University is responsible for signing off on the declaration now and not just the FSR. This verifies that a representative is in place and that we ensure certification is current.
