#### 2. Chair's Remarks

The Chair highlighted for the Board the continued increase in UNBC's research funding. Over the past five years, UNBC placed first among universities in its tier for the percentage of funding from the Canadian Institutes of Health Research. UNBC received \$7.7 million over the span, representing 12.6 per cent of UNBC's total research income.

The Chair advised that the Call for Nominations for the Faculty and Student Board members will be going out.
