- UNBC Environmental Engineering Students will be participating in the Compost project
- An updated budget and project plan will be provided to the GUPC for approval on May

13. STARS Update (information) – D Claus, D Smyth, K Aben

- Continuing the data collection phase and have begun to enter data into the online reporting tool
- On track to meet August 20 deadline.

14. Idle Free Policy

- PEC has approved an Idle Free Policy to discourage unnecessary idling on campus.
- This policy marks UNBC's second sustainability-related policy (the first is a Carpool Policy).

15. PEC Action Item - Fee for Bottled Water

- PEC has received multiple requests from various campus groups regarding the elimination of bottled water from campus.
- PEC requests that the GUPC discuss a "SIN tax" on the sale of bottled water
- It is estimated that the cessation of bottled water from campus would result in a substantial loss of revenue to student clubs, due to the terms of the University's current Beverage contract.
- It is unclear whether or not a SIN tax on bottled water would also be in violation of the beverage contract terms and therefore also result in a loss of student club revenues.
- If the goal is to discourage the use of single-use containers and reduce waste, it was suggested that pop bottles be taxed as well.
