- Rob Van Adricham:

- Expand the role of UNBC in Bioenergy and Carbon Policy discussions
- For UNBC to become a leader in public education concerning bioenergy
- Host a series of lectures/workshops about energy in Northern BC

- Alex Lautensach:

- Public hearings on the Enbridge pipeline have been in full swing in the region for a couple of months now. Alex gave a 10 minute presentation to the panel in May, 2012. Many citizens with different backgrounds gave presented their points of view. They expressed unanimous opposition to the Enbridge pipeline project for a variety of different reasons. The government has now removed all decision-making power from the panel.

- The NW campus is currently between regional directors. Alex has prepared a list of items about sustainable operations to discuss with the new regional director.

- Sarah Foot:

Motion: Establish the length of the term of the Alumni Representative position at the GUPC to be 2 years with the possibility of renewal. *Motion passed*. (Gail Fondahl/Ken Wilkening)

- Kyle Aben: we are applying for funding from the Fraser Basin Council to install a two-station electric car charger in parking lot A.

- Sarah Boyd: Artists in the Garden update. Part of this event will take place at UNBC. UNBC decided to co-sponsor this event.

- Transit: following up on conversations with the City of Prince George Transit Supervisor to install a pro-pass for faculty and staff
