- Following on year of Green Fund submission, it has become clear that there is a need to
 establish an accounting structure for the purpose of tracking all Green Fund project
 expenditures and ensuring that all University purchasing policies and procedures are
 being met.
- A Green Fund accounting proposal was presented (see attached) and will be brought to the Purchasing and Finance Departments for feedback.

- STARS data collection is still underway
- Some data has been entered into the online reporting tool
- With the establishment of the Green Teaching Working Group further progress will be made on the Teaching and Research sub-section of STARS

6. Roundtable (information) – All members

- The final Year of Science Forests and Carbon Workshop will be held in Quesnel
- PICS Director will be visiting UNBC on June 10
- PICS will be sponsoring 5 students to attend the International Student Energy Summit in Vancouver on June 9-11
- Climate Action Secretariat has given approval to go ahead with a carbon sequestration offset project; this will be a great first project for the Carbon Neutral Working Group
- An Energy Policy has been sent to PEC and a Strategic Energy Management Plan will be presented on Monday June 6
- UNBC will be testing several hand dryers in various locations on campus; the dryers will be compared with paper towel usage to determine if the dispensers should be replaced
- A Fredeen has been named with Carbon Management Theme Leader with PICS
- Some members of the GUPC and UNBC are assisting with the development of an Active Minds Summer Camp module called "It's Easy Being Green"
- Bike to Work Week will be held May 30-June 5
- UNBC's Carbon Neutral Action Report for 2010 was submitted on April 30 and will be made public June 30
