### 1. Approval of Agenda

#### 2. New Member Introduction

- D. Smyth introduced and welcomed new Regional Campus member A. Lautensach to the committee
- A. Lautensach provided the committee with a brief summary of his background

#### 3. Updates

D. Smyth provided committee with updates related to Bottled Water Free Day (March 11<sup>th</sup>, 2010) including results from a Bottled Water vs. Tap Water taste test which revealed that 79% of the participants preferred the taste of tap water over bottled water of could not taste a difference.

## 4. Call for Green Fund Proposals

- D. Smyth revised the Green Fund Proposal Guidelines based on the GUPC's comments during February 19 meeting
- D. Smyth asked if the committee had any final comments before a formal call for proposals was made
- A. Fredeen suggested adding an additional criteria related to proposals being evidence based
- T. Fuson concerned about proposals losing funding after 12 month period
- K. Wilkening added that internal guidelines must be established for working groups to review proposals including timelines for speeding up to approval process
- R. van Adrichem asked if proposals that are unsuccessful during Intake 1 will be automatically put forward for Intake 2
- N. Ehlers suggested that unsuccessful proposers should re-apply
- N. Nowak agreed that unsuccessful proposers should re-apply
- K. Wilkening added that GUPC working groups should provide feedback then suggest that applicants resubmit

MOTION: Accept Green Fund Proposal Guidelines with suggested changes.

- Sustainability Assessment
- K. Wilkening summarized that during previous discussions the GUPC suggested that
  working groups should be formed according to the various aspects of sustainability (i.e.
  waste, transportation, food, carbon neutrality, etc.)
- K. Wilkening asked how the Green Fund working groups will be structured
- A. Fredeen expressed concern about having too many working groups
- R. van Adrichem suggested the formation of a 5 member Green Fund working group for evaluating proposals with GUPC representation from the following: student, faculty, operations and 2 others.
- D. Smyth recommended that (a) the Green Fund group be structured as a GUPC subcommittee and function as a body to evaluate and recommend proposals to the GUPC and (b) establish working groups (as previously suggested) with representation from outside the GUPC

ACTION: K. Wilkening to coordinate the Green Fund Sub-Committee

- D. Smyth concerned that UNBC has not completed a comprehensive sustainability assessment which is crucial to setting targets and making progress towards goals
- D. Smyth identified the Sustainability, Tracking, Assessment and Rating System (STARS) as the most inclusive assessment framework
- A. Fredeen suggested that once the initiative has been advanced over the next year, we can assess our progress
- D. Smyth suggested that parts of the assessment can be completed through course credit (i.e. Environmental Studies course requirements)
- Z. Meletis suggested that social research methodology classes could participate in research design and data collection
- K. Wilkening proposed that the Green University Strategy be used as a starting point for evaluating our progress towards sustainability
