(a) **Coordination and Leadership Roles**

July 2025 – present: Graduate nursing program coordinator for NP(F), thesis, project streams.

September 2022 – July 2024: Post-Graduate Nursing Programs. Coordinator for Rural Nursing Certificate Program (RNCP) and MScN which includes the family nurse practitioner, project, and thesis streams.

Key Duties RNCP:

- Provide direction and support for faculty and staff delivering a seven-course postgraduate certificate that includes two certified practice courses
- Maintain and enhance relationships with practice partners from health authorities around the province
- Ensure certified practice courses meet program approval standards set by BCCNM
- Review and support hiring and orientation of faculty, assist to solve student issues alongside Advisor and/or faculty.
- Oversee curriculum and evaluation of all RNCP courses
- Work with undergraduate coordinator to support the cross-listed courses so that RNs and 3rd or 4th year students can be in the same course
- Work with placement team and/or faculty and/or practice partners to support excellent clinical placements for students
- Chair meetings, write reports (School of Nursing, BCCNM)

In 2022 a learning pathway for the emergency course was initiated, allowing 6 students in the 4th yr undergrad to complete the course and be hired into a NH training line. We also initiated a pilot with RhPAP in AB for the perinatal course. These pathways were successful and are continued for 2023. RhPAP did not send students for 2024 due to HHR shortages.

Wrote a proposal and received funding through a WIL grant to initiate a rural nursing learning pathway.

In 2023 wrote a proposal and received funding from the MoH to develop prescribing modules as required education for all RNs in certified practice to learn the competencies associated with the new prescribing standard. Curriculum updates undertaken include separating a CDM, wound care and palliative course so that 4th year students will for the first time be able to take a focused palliative care course as an elective. Member of the DST Steering Committee and Rural and Remote Working Group to revise and update certified practice DSTs and competencies.

In 2024 the prescribing course is now live. Met with provincial group representing MoH, RCCbc, NH and PHSA to explore curricular changes and options for modes of delivery for both the emergency course and Remote Nursing certified practice, to support rural nurses who also work in emergency to feel more confident and competent during times of severe staffing shortages, ED closures and diversions. This work will inform the province's rural healthcare framework.

Key Duties MScN:

- Lead and oversee activities related to application and admission cycle, orientation, FNP and GPC committees
- Coordinate activities related to faculty hiring and onboarding, curriculum renewal, evaluation of courses
- Work closely with the program Advisor, Manager, Chair and Clinical Placement Team for delivery of the program, addressing student issues or concerns, sustain excellent clinical placement opportunities
- Support faculty to address student performance or progression concerns, maintain curriculum and objectives towards the ELCs
- Meet regularly with internal (Chair, Manager, Grad office) and external (Health Authority, MoH, NPS, PSFS, NNPBC, BCCNM, other NP program coordinators) to support delivery of high quality FNP education to equip graduates to provide safe, competent, ethical community-based primary health care focusing on rural or northern communities

In 2022: Rewrote ToR for FNP and GPC committees; support onboarding for new faculty in sessional, lecturer and TT positions; re-developed student orientation activities; initiated a repository in the library for NP students with help of the Health Sciences librarian; developed and implemented a learning survey pilot as a format for course evaluation; provided motions to revise 2 sections of the calendar pertaining to requirements for a cultural safety course, active practicing BCCNM licensure and exceptional circumstances related to clinical placements. Oversight for planning and implementation of One45 software to replace Typhon and fill a gap for needed information related to curriculum mapping, update of content, delivery methods, and evaluation; support for faculty in areas of student communication or

misconduct; support faculty requiring absences from work; addressed issues related to scheduling within DCU, changed restrictions for FNP courses to allow others (e.g. Project MScN students) to take some courses, developed process for communication between instructors and students via Advisor to ensure clarity related to synchronous vs asynchronous class times prior to the course starting, initiated conversations to use a Moodle shell for faculty resources; changed application process for FNP to improve time from grad office to program; met with ARC to facilitate knowledge exchange in terms of accommodations for RNs required to be fit for clinical practice; contributed to BCCNM report for FNP.

In 2023: Presentation to NH to support NPs in NH to be preceptors for UNBC NP students, held session for grad faculty in learning to supervise graduate students, support new faculty to complete PAR process, navigate faculty leaves to backfill teaching for 605 and to complete review of NP applications short one committee member, create plan for mapping curriculum that will include new ELCs that will be introduced in Jan 2024. Create new clinical faculty model to be implemented Sept 2023, approved via FNP committee and SoN committee. Organize and Chair FNP retreat in May to plan for expected seat expansion of 100% including drafting new single sequence for the FNP program to replace the PT/FT streams based on 70% students completing in PT stream already and to reduce complexity of tracking cohorts and reducing HR burden with projections that change etc. Rewrite CF roles and responsibilities document. Re-write Handbook substantively. Re-write preceptor letter substantively. Re-write the “generic approach” letter for potential new preceptor substantively. All re-writes done with eye to align but not duplicate Calendar information. With Associate Registrar, re-wrote the application process and created new forms and triage system, held webinar and contributed to an applicant guide that is available on the website for applicants to the program.

Completed the eval pilot and submitted the report to the SoN committee. Identified need for course re-development specifically for 607 and 798. Updated process for completing SPECO, for submitting CRC and imms.

Wrote motions to change wording to remove CRC from Calendar and to update sequence.

Assisted in hiring process for Assistant Manager position within the SoN.

NOI to BCCNM to change program sequence, met w MoH / PSFS to confirm sequence change, approved.

Created clinical process document to support staff and faculty to delineate timing and responsibilities related to placements, honorarium etc.

In 2024: Updated NMPT process and placement allocations to strengthen commitment to offering students clinical experiences in rural and northern communities. Updated a process document created in 2023 intended to provide a wireframe outlining components of the program requiring further work and collaboration between faculty and staff, e.g. the website, student placement selection, review of curriculum and program documents etc. Requested biweekly meetings with manager and staff to implement a shift of all program and process documents to SharePoint, improving transparency and visibility of program operations to faculty and staff who need to have a common understanding of responsibilities and process. Implementation of a planner tool is underway for staff and faculty to be aware of relevant program timelines (e.g. sending preceptor letters) and which role is assigned various responsibilities (this was necessary due to staff changes and new roles added to the team over the past 2 yrs). Curriculum mapping complete with new ELCs and being refined in terms of what is taught where. New clinical model nearing end of one year pilot and intention is to keep and continue to refine with the CBL / seminar model and faculty participation in placement selection benefitting students and faculty. One45 implemented and operating well, eval process to inform NP Skills weeks in progress. Continue to meet regularly with coordinators of other programs. Initial meetings with faculty complete in aligning courses within new sequence which will start F24. 40 students admitted for F24. Motions to update pre-reqs and major restrictions and to reflect sequence change approved through Senate in May.
