

Wildlife Dangerous Tree Assessor Certificate - Participant Selection & Preparedness Checklist

The Wildlife Dangerous Tree Assessor Certificate modules are intended to provide professionals and technicians working in the areas of forestry, resource management, parks management, wildland fire protection, arboriculture, geophysical exploration or a related field with a professional development opportunity. This Certificate Program is not an entry level training opportunity.

Candidates must have the minimum course prerequisites at the time of registration. The Pre-Training Participant Checklist can be used as a tool to guide one's selection of participants for custom course modules and to ensure chosen participants are prepared to attend the course module(s).

It is the responsibility of the company requesting a custom course to ensure participants that are chosen meet the minimum prerequisites prior to sending them to a course module. At each custom course offering, participants are required to self-disclose prerequisites that they meet. This is one's personal declaration that they meet the course prerequisites for the course module they are taking.

A false declaration or misrepresentation is fraudulent. Should one not meet the necessary course prerequisites, they will be denied certification.

Three or more years of practical field (work) experience in the course field (forestry related work experience provides context knowledge for tree assessing and decision making processes)?		
Grade 10 equivalency in reading, writing and arithmetic skills (this course is technical in content, requires note taking and reporting, calculations of %, use of field guides)?		
Ability to identify tree species native to BC (ID species based upon bark, stem, branch, needles/leaves, cones; live and dead)?		
Proven forestry mensuration skills (e.g., determine diameter, height, horzontal distances, lean, stem cross-section)?		
FIRE MODULE additional requirements (at least one of the following)		
Recent fireline experience of a minimum of 10 days in past three years (i.e., this is NOT an entry level job opportunity course)? OR		
Experienced in assessing trees in Harvesting/Silviculture or Parks (minimum of five days of documented assessment in previous year)?		

SPECIAL NOTE: The duties of a Wildlife Dangerous Tree Assessor requires that the person registering will have the above prerequisites skills. This course is NOT for persons hoping to gain employment so that they can develop these prerequisite skills, knowledge and abilities.
