**Suggested Institutional Priority:** This joint major does not introduce new resources, faculty, or staff, and does not introduce new courses, but provides a new organization of study drawing from the existing programs of Anthropology and Political Science.

Despite COVID-19 era related challenges, SAAS met regularly and when special needs arose (e.g. acquisition opportunities).

We informally advised students seeking to acquire and install a piece of memorial art to honour deceased NRES graduate student Dan Larson. We also alerted the university to the fact that UNBC needs a memorial art (and other options) policy for when such community losses arise. Erica Hernandez-Read offered to be a part of addressing this when it is underway.

2) SAAS Art Acquisitions Policy: <u>The Art Acquisition Policy</u> and the <u>University Artworks Acquisitions</u> <u>Procedures & Guidelines</u> are both available on UNBC SharePoint. (approved: S-201308.09)

# 3) Update on SAAS-Arts Council combined call for improved arts governance at UNBC:

- **3.1 Background:** In March 2018, Heather Sanford and Tim Tribe met with SAAS members to discuss former President Weeks' proposal for a new University Advisory Committee on Art.
- **3.2 Segger Report:** In April 2019, Dr. Martin Segger (retired Director of the University of Victoria Maltwood Gallery) was hired by the UNBC Governance Office to conduct a review of the present governance structure of the Senate Artwork Acquisitions Sub-committee (SAAS) and to provide recommendations for the future collections management of the University's artworks. Segger met with

administration, members of SAAS, UNBC Arts Council and Library administration. His report was submitted to the University in August and was received by SAAS in October of 2019.

# 3.2.2. SAAS-Arts Council joint letter calling for improved arts governance at UNBC.

Was submitted to visiting governance auditors and PEC members in summer 2021.

#### 3.2.3. SAAS follow up on the letter

A related motion was presented at Senate in January 2021. It passed.

# 3.2.4. University follow-up on the letter

SAAS continued to follow up between Winter 2021 and Winter 2022 on our calls for improved art governance at UNBC. Dr. Payne and others agreed that action should be taken. A new **UNBC Arts Governance Working Group** has been struck to strategize on how to improved arts governance at UNBC.

# 3.2.5. Current status of the UNBC Arts Governance Working Group

We have met twice (March 16<sup>th</sup> and April 21st), and are currently considering how to develop immediate vs. longer term plans for improved arts governance at UNBC. Future meeting dates planned are June 23, September 15, and November 2. Thank you to Alexandra Parent and all of those serving on this Working Group. In the meantime, SAAS suggests that (active) art acquisitions be paused (noting that community-driven opportunities will likely still arise and must be responded to).

SAAS continues to work the UNBC Arts Council, and this new committee as necessary.

# 4) Acquisitions:

# 4.2 Victor Morris (Fort St. John):

This is a collection of 25 "original prints" by Victor Morris of Fort St. John, owned by Pearl Harris of Prince George. We (largely Erica Hernandez-Read) spent weeks trying to find out about the artist and the art. In the end, SAAS recommended the acquisition of only one piece as it spoke to Indigenous struggles and resistance. However, at the time of this report, we are still waiting to confirm the donor's wish to continue with this donation.

# 4.3. Michael Rees (Vanderhoof):

Michael Rees, was a prolific artist, well-known in the northern BC art community, who tragically passed away in early 2022. His family was connected to SAAS by George Harris, curator of Two Rivers Gallery, with an offer of works completed by Rees. This incredibly generous offer was offered to us far below market value simply as a means through which to raise funds to establish a student art scholarship in Rees name. The artworks were delivered by the Rees family and funds are currently being identified to provide towards this scholarship. SAAS members felt incredibly confident in accepting this donation as George Harris also selected pieces from this portfolio for the Gallery's permanent collection. We are considering a possible payment, in collaboration with the UNBC Arts Council, as sending funding towards the scholarship will benefit the family (and community!) more than a tax receipt.

# 5) Indigenous Art Commission Project (proposal solicitation began in 2019; work currently in progress):

Please see the previous (2019-20) SAAS Report for details on the background of this project. A proposal by renowned Kwakwaka'wakw artist and film maker, <u>Simon Daniel James</u> was accepted and the work is underway. Only the first portion of the three-part contract has been initiated so far (initial payment at start of project; 50%; and final). Upon consultation with the artist, Dr. Meletis recently worked with UNBC Procurement to extend his contract until October 1, 2022.

# 2020-2021+ (reporting until Jul '22) Annual SCAAF-SAAS Report to Senate

From 2020-July 1, 2022, Zoe Meletis remained the main contact with artist Simon Daniel James. She connected with him multiple times a term to see how he was doing, check on progress, etc. The artist's timeline was delayed for various substantial reasons beyond his control, including COVID-19 era impacts. The piece is now underway: the wood has been acquired, cured, and cut into initial forms. The artist is currently testing techniques for imprinting images on the "arm" aspects of the dial/central part of the piece.

Additionally, Zoe Meletis/SAAS requested that a university level committee referred to as "The Indigenous Art Council" be formed to properly prepare for the installation, welcome, and celebration of the piece, including attending to local Indigenous protocol. This is particularly important since the artist is Kwakwaka'wakw (not from this territory). We thank all who have participated in this committee to date, particularly Dr. Henry Harder and Mr. Brandon Prince, as well as Theresa Langford, for trying to organize us and keep us on track.

Erica Hernandez-Read and Zoe Meletis, after careful walking survey of the campus with various locational and curatorial considerations in mind, presented a PowerPoint slide deck of possible locations for the piece. To date, no firm decisions have been made but the location that generated the most excitement from the committee and the artist was Wintergarden—the idea being to hang the piece up above the Wintergarden, so that it will be viewed as a central piece, welcoming entrances from both the front and back of the space. The artist has prepared similar pieces for similar locations and could imaging adjusting the design to include suspension and being viewed from both sides. A discussion remains to be had about final location, the forms of accompanying curatorial and educational materials to be included, and the location of such pieces.

The artist estimates that the piece will arrive in late summer/early fall. Zoe Meletis recently sent an email reminding Mr. Prince and Theresa Langford about its pending arrival and trying to re-connect with the committee. Important work must be done this summer in order to be prepared for its arrival.

### 6) Art Storage update:

Some good conservation news – in March 2022 UNBC received a generous donation of art storage racks valued at approximately \$18,000, from Two Rivers Gallery at no cost. We register our thanks and appreciation here, and we also thank UNBC Facilities for assisting us with pick-up and delivery. While these racks will not solve our art storage issues, they are a welcome addition.

We are currently seeking a new Chair.
- We also thank **Trinity Posteraro**, Weller Library Administrative Assistant, for acting as SAAS Recording Secretary and **Dr. Bill McGill**, Interim University Librarian, as well as **Kevin Stranack**, University Librarian for approving her time contributions.
- We thank all SAAS members and ad-hoc contributors who have worked tirelessly to support the UNBC Art Collection, meeting regularly, circulating documents, making recommendations, raising funds, and liaising with various actors at UNBC. We look forward to a future of improved art governance at UNBC.

# **Anti-Racist Pedagogy**

Anti-racist pedagogy "begins with the faculty's awareness and self-reflection of their social position and leads to the application of this analysis not just in their teaching, but also in their discipline, research, and departmental, university, and community work" (Kishimoto, 2018, p. 540). Join us for a discussion on cultivating an anti-racist pedagogical practice, where we will share commitments and experiences from a student, staff, and faculty perspective. We will share practices you can engage in to sustain a commitment to being actively anti-racist in all facets of your work.

Tari Ajadi (he/him) is a PhD candidate in Political Science at Dalhousie University and a Predoctoral Fellow in Black Studies at Queen's University. His dissertation research compares how Black activists in mid-sized municipalities strategize to prompt change in policing and in health policy. He is a member of the Board of Directors of the Society for Teaching and Learning in Higher Education. In 2023, Tari will begin as an Assistant Professor in Black Politics in the Department of Political Science at McGill University. He holds an MA in Political Science from Dalhousie University.

Tyrell Chambers (he/him) is a 2nd year student in the teacher's college program at Nipissing University. He also completed an undergraduate degree at Nipissing majoring in English studies and minoring in Geography. In 2021, he became an executive member of NUBASE (Nipissing University Black Association for Student Expression). He currently serves as the director of the Mentorship Program of NUBASE. In 2022. Tyrell joined the Nipissing University Teaching Hub as an Online Learning Partner at Nipissing with a focus on Anti-Racist Pedagogy. He has loved his experiences so far within this position and can't wait to continue educating others about diversity and inclusivity!

Heather Carroll (she/her) is the Senior Instructional Designer at Nipissing University and a designer of anti-racist adult learning programs across Atlantic Canada and Ontario. Prior to transitioning to post-secondary teaching and learning, Heather taught grades two through eight in St. John's and Halifax. She holds a Master's of International Higher Education from Loyola University Chicago, and a Master's of Learning and Teaching from Harvard University. As a scholar-practitioner, Heather has facilitated over 100 virtual learning sessions since 2020, engaging thousands of educators in developing a teaching practice that cultivates equitable learner success.

Universities have been built on mystification and exclusion; this has been palpable for excluded groups and pernicious for the privileged for a long time. This session will take, as a starting point, these two statements:

- 1. the systems are broken
- 2. the systems are working exactly as designed

In reflecting on the systems within which we learn, lead, teach, and live, this session will encourage attendees to think about how we can build systems that foster resilience where individuals flourish in communion with others. Hope University, at its core, is an open-hearted invitation to dream and scheme, imagine and build, challenge and reflect. It is a de-centering or re-orientation of systems and structures in order to look at our institutions with fresh eyes.

Dr. Jessica Riddell is a Full Professor of Early Modern Literature in the English Department at Bishop's University (Quebec, Canada). She holds the Stephen A. Jarislowsky Chair of Undergraduate Teaching

Excellence at Bishop's University; in this capacity, she explores innovative teaching and learning practices, creates mentorship opportunities for students and faculty, and participates in a wide range of conversations at the national and international levels. Dr. Riddellis also the Executive Director of the Maple League of Universities, a consortium of four universities – Bishop's, Mount Allison, Acadia, and St. Francis Xavier – that share a focused commitment to quality undergraduate education. She works across the four universities to support high impact practices as part of a 21st century liberal education. An award-winning educator and scholar, she has published on Shakespeare, institutional culture change, Inter-institutional collaborations, experiential learning, and inclusive high impact practices. Her forthcoming book, with collaborators Dr. Lisa Dickson and Dr. Shannon Murray, is called Shakespeare's Guide to Life, Hope, and Learning (UTP 2023). She is currently finishing a book called Hope University: Building Resilient Systems to Individuals Don't Have to be. Dr. Riddell was awarded the 3M National Teaching Fellowship in 2015, the highest recognition in Canada for educational leadership. She is an ardent fan (and wrangler) of two tiny humans – Sophie and Henry – and two fur babies – Marlowe and Hatley. In her efforts to follow Winston Churchill's maxim to cultivate three hobbies for "relief, repose, refreshment," she runs (slowly), paints (badly), and reads mystery novels (indulgently)

# Midterms & Final Exam Prep



The CTLT recommends that each instructor consider their mid & end of semester assessments. We want to discourage students from coming to campus while ill and would like to provide flexible options for them during midterms and final exams.

# We suggest:

- Plan an online version of your exam as a backup for those students who may not be able to attend. These assessments take time to build and the CTLT Instructional Designers can help assist you in creating exams online to suit your course's specific needs. If you do not know who your assigned CTLT Instructional Designer is, please contact ctlt@unbc.ca<sup>3</sup> and they will direct you.
- Please give at least two weeks' notice to your Instructional Designer for preparing an online exam we have a high volume of requests and need to plan our time to make sure we can accommodate everyone's exam needs.
- Consider creating a "take home/open book" exam that ensures the most flexibility & reduces student stress.

## How to prepare your online exam:

- 1. Your CTLT Instructional Designer can batch upload multiple choice, true/false, short/long answer questions. These options save you time so you do not have to create individual questions in moodle.unbc.ca one by one. Multiple choice & true/false questions are automatically graded within moodle.unbc.ca. Short answer and paragraph or essays will need to be graded by the Instructor or TA.
- 2. **To discourage cheating,** it is best if Instructors create a slightly larger question pool so we can set up the test to display a randomized subsection of questions to each student. We can also choose settings like displaying one question at a time, and having no backtracking allowed, if necessary. We can also shuffle the answers within the question itself (special format restrictions apply).
- 3. We are available to review exams and quizzes that you have set up yourself since Moodle is new and has many confusing test options. You are most welcome to contact a CTLT Instructional Designer to double-check your settings to ensure there are no difficulties during the exam.
- 4. **Some students may require ARC (Access Resource Centre) accommodations** such as extra time to do the exam, or having the exam take place on a different day. International students may also request a time-zone adjustment. Please contact your CTLT Instructional Designer for assistance.

**Open Book, "Take Home" Exam** – Easiest to implement, you usually don't have to worry about creating separate ARC accommodations as they are usually taken care of by the extra time & flexibility allowed by a take-home exam. You can give 12, 24 hours for students to complete and upload the exam/paper to moodle.unbc.ca. Less stressful for students.

**Completely Online** – students answer all questions in moodle.unbc.ca. Mix of multiple choice, true/false, short answer, long answer, case study questions. Long Essay questions should be written in a word doc and submitted as a word document to the test.

Part Online (multiple choice, true/false) and Part Submission (word document, excel sheet or scanned paper with calculations) This is good for exams with a lot of calculations or technical drawings. (MATH, PHYS, CHEM, ENGR, etc.) \*\*\*\*VERY IMPORTANT\*\*\* Make sure students practice submitting a scanned document before the actual exam.

Scanned Submission – Instructor posts the exam questions as a downloadable PDF or Word document. Students print it and complete answers offline, or just write answers on a piece of paper. Students then submit their answer document as either word doc, PDF or scanned document of handwritten answers. This option is good for exams with a lot of calculations or technical drawings. (MATH, PHYS, CHEM, ENGR, etc.) \*\*\*\*VERY IMPORTANT\*\*\* Make sure students practice submitting a scanned document before the actual exam.

**Exam using an Assignment Dropbox** – not recommended unless it is a "Take Home Exam" with lots of time given (e.g. 12 hours, 24 hours). ARC accommodations and time variations are hard to set on this type of exam.

**Emailed Exams** – not recommended. If you do email exams, please be extra aware of ARC students who may need to start the exam early or have extra time.


