**2.0 Presentation:** Degree Quality Assurance Board - Program Changes and the Determination of New Degrees - Dr. John McNeill, Director - Academic Operations and Quality Assurance

Links to the Quality Assessment Process and Criteria handbook were included on the agenda.

Dr. McNeil presented an overview of the Degree Quality Assessment Board (DQAB) and its role in evaluating new degree proposals and significant program changes. The presentation emphasized the importance of aligning with provincial standards, understanding thresholds for curriculum revisions, and engaging early with governance bodies. Timelines for approval vary widely depending on the nature of the changes, with external consultation often required. Key takeaways included strategic planning, clarity in learning outcomes, and proactive communication with DQAB.

However, the idea is considered valuable, particularly in evaluating workload distribution and overall effectiveness. With the arrival of a new provost, this review may be proposed as a future initiative. It remains on the agenda as a potential area for assessment and feedback gathering.
