#### 3.1 Master Plan

### 3.2 Green University Committee Structure (revised diagram)

## 3.3 Status of funding request for Feasibility Study (Bio-energy)

- The federal government has 35M available in its pine beetle recovery program.
- Deadline is this Monday for a proposal to do a feasibility study on implementing a biomass energy project at UNBC in 2008/09.
- This funding would directly relate to Item #3 in the Canada's Green University brochure.
- The study will provide a tool for potential funders.
- The pilot project will result in the installation of a pellet boiler and a comparison of pellet vs natural gas emissions.
- Don Cozzetto and Allan Berezny will be meeting with UNBC Vancouver Advisory Committee and will speak on UNBC's green initiative with the hopes of gathering additional ideas for funding.

## 3.4 Green University Coordinator Position Update

- Jim Randall presented a brief position description for the position (distributed and attached to minutes)
- Position will be titled Coordinator, be under contract, and be funded by the Provost office for the first six months. The position will then be made permanent with budgeted University funding.
- A potential visiting professor has been approached to fill this position for six months.
  This person has expertise in "greening" and will be strategic in this bridging position.

### 5. Green Day

- It was suggested that a Green Expo (involving community) and a Green Day (UNBC community) be combined to create a professional and quality event that the community will want to attend. Booths could be set up where employers could highlight their sustainability practices and promote jobs within their companies. UNBC could present green food, etc. This event could possibly take place in Sept/Oct 2008 on a ProD day to enable high school students to attend. It was also suggested that the Green Day/Expo could be part of the responsibilities of the new Coordinator of the Green University Initiative. Perhaps a "green" keynote speaker and government officials could be invited.
- It was decided to go ahead with a smaller university event in the early spring and perhaps a bigger event in the fall. It was suggested that a class be involved in the planning and outcomes as part of a class assignment. The new coordinator and PIRG would also be involved.

ACTION: Ken Wilkening and Art Fredeen to determine if class involvement is feasible and exactly what it would entail.
