## Commentary

- The Canadian Equity peer group median gained 2.71% over the month. CC&L ranked in the top decile over the month while Beutel Goodman ranked in the bottom quartile.
- The US Equity peer group median gained 4.21% over the month. Beutel Goodman lagged the S&P 500 Index and ranked in the bottom quartile over the month.
- The International Equity peer group median rose 3.98% over the month. Fiera exceeded both the MSCI EAFE (Net) Index and the peer group median over the month.
- The Global Equity peer group median gained 3.60% over the month. Hexavest lagged the MSCI World (Net) Index over the month but exceeded the peer group median.
